AFFIDAVIT FOR ARREST WARRANT**

I, DEPUTY M. REYNA, A LICENSED PEACE OFFICER UNDER THE LAWS OF THE STATE OF TEXAS, EMPLOYED BY THE NACOGDOCHES COUNTY SHERIFF DEPARTMENT, DO HEREBY SOLEMNLY SWEAR THAT I HAVE REASON TO BELIEVE AND DO BELIEVE THAT BEFORE THE MAKING AND FILING OF THIS COMPLAINT, THAT Paul Vincent Anderson W/M DOB: 05/02/1964 DID ON OR ABOUT 12/03/2020, IN NACOGDOCHES COUNTY, TEXAS, then and there, with the intent to harass, annoy, alarm, abuse, torment, or embarrass, Lori Tanton W/F DOB: 01/18/1967, sending a repeated electronic communication message, to-wit an E-mail, to Lori Tanton, in a manner reasonably likely to harass, annoy, alarm, abuse, torment, embarrass, or offense another. To-wit, after being told to not make further contact with Lori, the content of the e-mail, according to Lori, is construed as harassment. This method, specifically the choice of words that Paul uses in the e-mail to engage Lori, is not one that is commonly used in an everyday professional setting. Said content would lead a reasonable and prudent person to believe it to be harassing.

MY BELIEF IS BASED ON THE FOLLOWING FACTS: AFFIANT IS EMPLOYED BY THE NACOGDOCHES COUNTY SHERIFF'S DEPARTMENT, NACOGDOCHES, TEXAS, ASSIGNED TO THE PATROL DIVISION AND IN SUCH CAPACITY IS A LICENSED PEACE OFFICER UNDER THE LAWS OF THE STATE OF TEXAS.


On 12-03-2020 at approximately 1320. Deputies responded to the address of 3073 County Road 898 in reference to a harassment call. Lori informed Deputies that Paul had contacted her via e-mail on 12-03-2020 at approximately 1110 hours. Lori forwarded a copy of the e-mail to the Deputies. The e-mail stated the following:

"Hello Lori, just wanted to remind you read your email below and then you will realize how full of crap you are".

Deputies looked into previous incidents involving both Lori and Paul and found that Paul had been issued a harassment warning from Sgt. Rudisill on 09-25-2020, at Lori's request. Deputies contacted Paul in reference to this issue to which Paul confirmed that he did in fact send the e-mail on 12-03-2020.




